Their unwavering commitment to Masonic Ritual, education and Brotherhood inspires us all.

My Brothers, my Grand Lodge duties and travels during the past eighteen years have afforded me the opportunity to witness firsthand the generous Masonic spirit of so many hardworking Brothers, especially the Grand Line and Grand Lodge Officers, Grand Lodge Committeemen, District Deputy Grand Masters, Grand Lodge Staff Officers and Assistant Grand Lecturers, the Trustees of the Masonic Hall and Home, and the Livingston Masonic Library, Directors of the Masonic Brotherhood Foundation and Masonic Medical Research Institute and my hands within the field of Masonry, our Worshipful Masters and their Lodge Officers. All of these committed brethren promote the incredible experiences that we witness within our communities, our Grand Lodge, and our Districts and Lodges on a daily basis. My goal beyond the next 100 days is to work with our committees, elected and appointed officers and brethren all to enhance our communication, revitalize committees and improve the meaningful services that enrich the membership experience. We are blessed to have such a rich blend of seasoned, accomplished and knowledgeable Masons, such as our Past Grand Masters and Permanent Members, that we can draw from their experiences to further advance our journey.

To accomplish this, I have established seven pillars to serve as the guide during our labors:

- Our Three Precious Jewels
- Grand Lodge Leadership
- Masonic Education
- Membership Value
- Masonic Lodge and Building Governance
- Masonic Communication and Social Responsibility
- New York Masonic History

Our Three Precious Jewels

The Trustees of the Masonic Hall and Home (Masonic Care Community MCC), Masonic Medical Research Institute (MMRI) and Chancellor Robert R Livingston Masonic Library and Museum: your importance to New York Masonry and our Craft cannot be overestimated. From the first moment an orphaned child was brought to the Masonic Care Community, and for 130-plus years since, you have fulfilled the obligation of the Craftsman. Since 1958 the MMRI has served Masonry and Humanity and has embodied the very essence of our Masonic duty to Charity. Since 1850 the Chancellor Robert R Livingston Masonic Library and Museum has been a beacon of Light, whose importance I celebrate and champion.

Yet for all three, real challenges exist. In order to fulfill our duty we must have honest, thoughtful conversations as we collaborate to ensure that each of our Three Precious Jewels remains strong, meaningful and vibrant for generations to come.

Grand Lodge Leadership

I am refining the Grand Lodge Leadership structure by fully engaging our Grand Lodge Liaison Officers: the Senior Grand Warden, Junior Grand Warden and Grand Treasurer. These Brothers will have defined duties and responsibilities over those regions of the State in which they serve, as well as over designated Committees and Programs. While I will always be hands-on, having these Grand Line Officers engaged in such a manner will ensure that District Deputy Grand Masters, Grand Lodge Staff Officers and Worshipful Masters will be offered real assistance as they govern as well as have clearly defined sources of assistance. The Liaison Officers will assist me to further ensure real communication, accountability and real transparency within our Grand Lodge system of governance.

Furthermore, I am instituting a soft Grand Lodge policy that will prohibit a Brother from serving on more than one Board/ Foundation/Committee. This strategic shift will revitalize our leadership pipeline and prepare us for the future. I am also establishing systems to refocus the work of our Grand Lodge Committees, which will be detailed in the fall issue of the Empire State Mason.

I am further granting the authority to my District Deputies the ability to grant dispensations for Degree classes of more than five candidates. Additionally, I am introducing two initiatives to benchmark our Lodges and streamline our formal proceedings and processions.

1. Lodge of Excellence Program

This new program, The Lodge of Excellence, will identify the health of each of our Lodges, celebrate successes and offer real guidance and assistance to those

We will address many of the Constitutional and legal issues, shortcomings and deficiencies that have become apparent over the years. We will afford opportunities of discussion throughout the year and throughout the State with the use of in-person Town Halls as well as Zoom programming to ensure an informed electorate, and thereafter present several Constitutional Amendments at the 2025 Grand Lodge Session.

To that point, significant portions of our 2025 Grand Lodge Session will be open to New York members-only, to ensure honest, open discussion within the sanctity of our Session. There is no reason to air our challenges or disagreements outside of our New York Masonic Family.

Masonic Education

Brothers elected to serve their Lodge as Worshipful Master gather around our altars and obligate themselves to provide Masonic Education at Stated Communications. I have heard the calls from Lodge and District Leaders and Past Masters for the need to provide additional leadership resources beyond presentations or programs in meetings. I am proud to share that we have established educational programming that will include both in-person Regional Educational Conferences and virtual Zoom Programs and, for the very first time, an Esoteric Course of Study. Additionally, under the leadership of RW Bill Edwards, we will roll out the long-awaited Maxwell Leadership Program to offer enhanced Leadership Training to our brethren.

Membership Value

My goal for the Grand Lodge of New York is to show how Brothers best can work as an example for other jurisdictions to emulate. After all, "It's Called Brotherhood" is my motto for this Masonic year and has been my rule and guide for my work in the Craft. I want my fellow Brothers to share my pride in being a New York Mason and to support that, I have created unique events and programs meant to engage and excite our members.

- Save the date: our Grand Lodge will hold its first Masonic Con in Masonic Hall on January 17-18, 2025, with speakers and authors from around the country. Be on the lookout for more messages on purchasing tickets and the schedule of events in the weeks to come.
- A Masonic Retreat at Camp Turk where esoteric topics will be addressed by day and comradery and fellowship will commence at night.
- We are re-tooling the functionality of the NorthStar Program to ensure a steady stream of potential candidates, fair distribution of those candidates and oversight of our success coaches/mentors, to ensure that our newly Initiated, Passed and Raised Brothers receive the Masonic guidance and experience they deserve;
- We have established for our various Lodges and Districts new additional officers and programs with specific duties and responsibilities. These include the Lodge/ District Recruitment and Retention Officers/Programs, Lodge Youth Officers, Lodge Masonic Military Veteran Officers, Lodge Surviving Spouse Officers and Lodge Communications/Public Relations Officers to ensure that no member of our Masonic Family is forgotten or left behind and that our message both within the Craft and without is thoughtfully, purposefully and effectively

delivered.

- We are re-tooling, re-energizing and re-focusing the Masonic Brotherhood Fund Committee that not only spearheads our charitable needs, but ensures that our message of Brotherly Love, Relief and Truth is not a mere bumper sticker.
- I am pleased to introduce our newest Masonic Brotherhood Fund Campaign: The 1781 Society. 1781 marks the year our Grand Lodge was warranted. By pledging \$1,781 you will receive a distinguished medal symbolizing your commitment to our noble cause. I hope Brothers will join me as we embark on a journey of philanthropy and camaraderie, with the option of spreading your contribution over seven years (\$255 per year) or making a one-time donation.
- We are in the planning stage of a Camp Turk Fundraising Campaign that will culminate with a Grand Master's Polar Plunge at Camp Turk.
- We will be establishing at Masonic Hall a Men's Masonic Choir. For those interested, please contact RW Matthew George: wbrmatthewgeorge@gmail.com.
- Finally, we will continue our partnership with Craftsmen Online to provide Masonic Education and History through our podcast, virtual programs like the Reading Room and thought-provoking blog articles from contributors such as RW Samuel Lloyd Kinsey, Chairman, Custodians of the Work.

Masonic Lodge and Building Governance

During my travels to Lodges throughout our great State, I have found that every Lodge is special and each Lodge's history is very important. Some are older, others newer, but all share a common Masonic Legacy. Yet, most also share the same challenge of managing a Lodge and Lodge building and in recent years this task has grown even more complex.

To support our Masonic Halls and Temples I will introduce new programming to offer real guidance and financial support to our Masonic Lodge Building owners, including accounting and legal sub-committees to assist in the complexities of Lodge business and building ownership.

- We will introduce several draft manuals: Lodge Treasurer and Trustee Manuals to establish baseline protocols that Lodges and Districts must follow.
- We will require each Secretary to update his membership data in our M2 (MORI) system.
- We will require every Lodge to engage in the self-auditing program instituted several years ago but rarely followed.
- We will require that Lodge management safeguards and protocols be practiced by each Lodge.
- We will mandate that Lodge Secretaries, Treasurers and Trustees participate in Grand Lodge-sponsored Leadership Courses to ensure that best practices are how we conduct the business of Masonry in New York State.
- We will mandate that every Senior and Junior Warden, desiring a seat in the East, participate in the Road to the East, Master's Chair and Masonic Development Courses.

Masonic Communications and Social Responsibility

We live in the Information Age, where just about every member of society carries in his pocket a cell phone with more computing power than the original space shuttle. Yet, communication between the Grand Lodge and our Lodges Continues on page 5 – From the Grand East

and brethren is a constant challenge. This problem is only further exacerbated by the fact that many of our Lodges do not engage in social media or have any real web presence; and if they do, the calendar is from 2017. This is not a way to attract new members or engage current members.

Come September, I will require each Lodge Secretary to ensure that his Lodge's M2 (MORI) information is up-to-date and accurate. Each Brother will be required to provide necessary information to complete our system. Lodges will be required to have, at a minimum, a basic website. For those Lodges incapable of establishing such a social media or web presence, our Communication Committee will assist in this endeavor.

Additionally:

- We have established a Lodge Officer system to ensure that our Lodges will have the knowledge and tools needed to support our Masonic Youth, military veterans, surviving spouses and fallen Brothers.
- We will encourage Lodges and Districts to employ communication strategies within their Lodge and District membership, as well as to employ social media and web platforms for communication with membership and profane alike, and offer assistance through the Grand Lodge Communication Committee when guidance is necessary.
- We will encourage Lodges and Districts to promote their good works via press releases and other like means, and assist them when and where necessary.
- We will encourage all Lodges to engage in Charitable endeavors, and for those Lodges in need of guidance the Grand Lodge Charity Committee is able to assist in a multitude of pre-planned programs.
- We will celebrate our Masonic Military Veterans during the month of November, never forgetting those Masons who have served and continue to serve our Nation with dignity and honor.
- We will ensure Lodges are connected with their older brethren and encourage occasional Zoom meetings to include those brethren who have moved away from New York or due to health restrictions cannot travel, so they too can have an opportunity to remain connected with their Lodge.
- We will encourage Lodges/Districts to actively participate in the Surviving Spouses Program, demonstrating by action and deed that Surviving Spouses and Loved ones are always part of our Masonic Family.
- We will continue the District Public Relations Officer Program (DPRO) and refine its techniques as we further work to provide monthly email notification to our Worshipful Masters and Lodge Secretaries containing important news and events occurring within our Grand Jurisdiction.

New York Masonic History

Over the centuries our Grand Lodge has played a crucial role in supporting Masonic Lodges across the State, fostering charitable endeavors and preserving Masonic traditions and history. Today it continues to thrive as a coordinating body for Masonic activities, with a jurisdiction over nearly twenty-five thousand Freemasons and hundreds of Lodges in New York and Lebanon. Yet, many of the Masons who take their solemn

obligations in our Lodges are sadly in the dark regarding our proud history.

The first area we must address is a vacancy at the top. Our esteemed Grand Historian, RW Gary Heinmiller, has retired following eight years of dedicated and loyal service. As such, we are seeking Brothers who are interested in serving as Grand Historian to send their resume and letter of intent to RW Lorenzo Cesare, the Aide to the Grand Master at GMAide@nymasons.org. To support the efforts of the Grand Historian I will continue to encourage each Lodge to have a Lodge Historian.

To continue to shine Freemasonry's Light in our great State I have several programs to introduce:

- I am pleased to announce our Lodge History Contest as I wish to celebrate our Lodges by displaying Masonic memorabilia and Lodge aprons and artifacts in the display cases at Masonic Hall. Lodges interested in participating should contact RW Michael LaRocco, Executive Director of the Chancellor Robert R Livingston Masonic Library and Museum at MLarocco@nymasoniclibrary.org.
- We have further established new multi-tiered programs to celebrate our New York Masonic History with our Masonic History Projects:
- Our Walking and Driving Tour Program, headed by RW Ivan Boluarte, is creating walking and driving tours of Masonic locations within our State. We are seeking Brothers from all over the State to help map out their Masonic locations of interest within their own communities. Interested Brothers should contact RW Ivan Boluarte at Ivant55@hotmail.com.
- I am pleased to be partnering with RW Walter Cooke, Trustee of the Chancellor Robert R Livingston Masonic Library and Museum as he prepares a manual with clear and concise instructions on the proper manner of preserving Lodge documents and artifacts. Indeed, the Grand Lodge will be establishing a system to permit the borrowing of scanning kits to enable Lodges to better preserve their records, documents, aprons and artifacts.
- Throughout 2024-2025 we will be celebrating the 200th Year Anniversary of General and Brother The Marquis de Lafayette's return to the shores of the United States, and specifically his return to New York. Beginning in August 2024 the Grand Lodge, Districts and Lodges across our State will sponsor events to celebrate Lafayette with galas, parades, Degrees and events tracking Brother Lafayette's travels throughout New York State. My Brothers, these are just some of the initiatives in store for 2024. Yet, I am mindful that it will not be easy to change how we govern. DEPUTY GRAND MASTER





I want to begin by thanking you, the Brothers of the Jurisdiction of the Grand Lodge of New York, for allowing me the honor and privilege of serving you as your Deputy Grand Master for these next two years. Having the opportunity to work for you in this capacity is a dream come true. Being the Deputy Grand Master of one of the oldest Grand Jurisdictions on Earth is nothing to take lightly, and I do not. Down in Rockland County in the hamlet of Tappan, you will find the DeWint House. It was built in 1700 and visited twice by General George Washington. While there in 1780 he signed the death warrant for British Major John Andre, who conspired with Benedict Arnold to surrender West Point to the British. When he visited in 1783, Washington entertained British General Sir Guy Carleton to negotiate the British Army's evacuation of New York City. It is Masonic history and it is American history, all wrapped up in one place and it is ours.

And then there is the Masonic Hall on 23rd Street in New York City. It would take an entire issue of this magazine to adequately describe what we have at Grand Lodge. It is home to the Chancellor Robert R Livingston Masonic Library (14th Floor). Take advantage of our reading course program.  ${f F}$ or many, our physics career ended sometime around $10^{
m th}$ grade. That would be me. Before bailing on physics, I recall something from chaos theory called the "Butterfly Effect." It posits that the world is so finely interconnected that, for example, the mere flapping of a butterfly's wings on one side of the Earth is enough to ultimately cause a hurricane on the opposite side of the globe. Skeptical? Me too. Or at least I was until about six weeks ago.



I am required to take wind therapy fairly frequently on my Softail (Doctor's orders). Wind therapy is best done in groups and Masons are fortunate to have several Masonic motorcycle associations we can join. About six weeks ago, the Binghamton chapter of the Low Twelve Riders took a ride we had been planning for some time. The route took us from Hancock to Port Jervis along the Delaware River. Those who have been on that road know that it is truly scenic. I believe there were six of us wearing our Masonic "cuts" (vests identifying us as members of a Masonic motorcycle association). We headed south and parked at an overlook called the Crow's Nest high above the Delaware along with several other groups of bikers and sat there for half an hour exchanging small talk. Being Masons, food was never far from our thoughts and we ultimately headed back north in search of a pub. We found a great roadhouse called the "Outpost." It was fittingly named, as it was very close to the location of the Revolutionary War battle of Minisink. You may recall that battle: where colonial troops were routed by Brother Joseph Brant's Mohawk fighters.

Food and fellowship at the Outpost were in abundance. Several of the Brothers wandered around and checked out the outdoor bar and stage while the rest relaxed and chatted. At some point another group of bikers entered the bar and sat at a table very near us. This group of bikers also wore vests, although they did not look like ours. For the non-bikers among you there are certain protocols—dos and don'ts that are part of the bike world. Many of these rules revolve around vest patches. It's safe to say that it would be very easy to innocently violate a rule without ever having an idea you were doing it. I never did get a clear look at the cuts that the other gentlemen were wearing, but again—they were not like ours. We will just leave it at that.

During lunch (the burgers were great) I noticed that an extremely large member of the other group, patched as their

"Sergeant at Arms," seemed to stare in my direction. We finished our meal and our group got up and left. I was last to leave. As I walked past Sarge, he grabbed my arm and asked me if he could have a word with me outside. As a funny aside, one of his cohorts asked him if he needed any help and he just smiled and said no. I would be remiss in not further describing this gentleman. Let's just say he was enormous, covered in tattoos (not necessarily a bad thing) and didn't have a hair on his head. As we walked outside I noticed that my group hadn't seen any of this interaction and were now clustered around our bikes a good 40 yards away.

Several things went through my head. Had this been someone I'd prosecuted during my DA career? Was I current with my health insurance premium? Why had I been a distance runner instead of a sprinter? I tried to recall YouTube videos I'd watched about biker etiquette. What, if any, biker rules had we broken? I could think of none. As always, we were perfect gentlemen in the roadhouse, ever mindful of the fact that we were wearing Masonic emblems and were therefore representing the Craft.

The next couple of minutes passed in slow motion. Sarge looked (down) at me and asked me if we were Masons. Steering far clear of any "witty" responses, I told him "yes." At that, he thrust out his hand and shook mine.

"I just wanted to let you know that I got in a little bit of trouble a few years ago and was sentenced to community service. I did the service at three places. At the first two places I was treated very badly [cleaning up the language, here]. The last place I had to do my service was at a Masonic Lodge in Dover, New Jersey. I just wanted you to know that they were true gentlemen and treated me with respect. Thank you."

We shook again. I thanked him and told him that he had just made my day.

The Lodge located in Dover, New Jersey is called Acacia Lodge 20. In their spring newsletter this year the Worshipful Master wrote in his column "From the East" that Brothers should "see the square as more than just a tool for building. It's a symbol of doing what's right and being fair. Just like it ensures our corners are perfect, it teaches us to live with integrity, honesty and fairness. Let's think about what the square teaches us. It encourages us to always do the right thing and to treat others well. Whether we're in the Lodge or we're out in the world, let's use its lessons to guide our actions."

Brothers, like the wind caused by the butterfly's wings, the lessons inculcated in that Lodge made their way through time and space to a little pub on the Delaware river (and who knows where else). When Sarge thanked me I couldn't have been prouder to be a Mason. The Brothers in Acacia 20 truly put our fundamental beliefs into practice and the world is better for it. Let's do the same.

If the Lodge or the Committee gives an unfavorable report, it ends there and does not get put to Grand Lodge for a vote.

### **Credentials of Members and Returns of Lodges Committee**

This last year we put all our efforts into redoing the Degree Animation, along with creating a new Hiramic Drama Animation. We also were deeply involved in assisting our Grand Lecturer in staffing and portraying the Hiramic Drama for Unity Day, where we also witnessed the Grand Lodges of Connecticut, Delaware, New Jersey and Pennsylvania portray their rituals for the Opening and all three Degrees.

Our plan for 2024 is to assist the Masonic Regions throughout the state; do the Hiramic Drama for Lodges who cannot do it themselves; show the new 1<sup>st</sup> Degree Animation. We will also prepare for the 2025 International Grand Lecturers' Convention.

#### **Theodore Roosevelt Award**

The Theodore Roosevelt Award is awarded for exemplary service in the civil service sector. The award was named after Theodore Roosevelt, who was a Brother Mason, a New York City Police Commissioner, the Governor of New York, Assistant Secretary of the Navy and became the 26th President of the United States.

During President Roosevelt's term as President of the NYPD Board of Commissioners, he fought corruption in the police department, helped establish a Municipal Lodging House with the Board of Charities to aid immigrants, fought corruption in Tammany Hall, established Meritorious Service Awards for the NYPD and personally walked the beat with patrol officers to ensure things were being done. The journalist Jacob Riis wrote in his book, *How the Other Half Lives* "...that for the first time moral purpose came into the streets. In the light of it everything was transformed." The Theodore Roosevelt Award is awarded in his honor for exemplification of his tradition.

#### **Brotherhood Fund**

The Masonic Brotherhood Fund is the charitable arm of the Grand Lodge of New York. The Brotherhood Fund assumes a solemn responsibility, to alleviate the burdens of our distressed Brothers, their families, widows and orphans. It stands as a lifeline in times of unforeseen and often catastrophic tragedies. It helps our brethren and their families overcome some of their darkest moments. While we hope and pray that no one will ever need this assistance, the Masonic Brotherhood Fund has and always will stand ready to assist our Brothers, their widows and orphans in need.

Other than our main mission to support, aid and assist our Brothers, their families, widows and orphans, the Masonic Brotherhood Fund also provides vital support to organizations that are within our community. These include the Masonic Care Community, Masonic Medical Research Institute, Chancellor Robert R Livingston Masonic Library and Museum and Camp Turk and a variety of initiatives such as Disaster Relief, Military Outreach and our Masonic Youth Programs.

#### **Deputy Grand Master's Advisory Committee**

The Masonic Youth Committee empowers the Grand Lodge of New York to make a positive impact in the next generation of servant leaders. Working with New York's three Masonic Youth Groups—DeMolay, Rainbow and Triangle—the youth committee promotes and encourages a more vibrant culture of youth leadership and development. #### **Correspondence and Relations Committee**

The Correspondence and Relations Committee is a vital Standing Committee within the Grand Lodge. Its multifaceted role encompasses several key functions. First and foremost, the committee handles requests for mutual recognition and

amity from foreign jurisdictions. In this role it safeguards the brethren of the Grand Lodge of the State of New York, ensuring they do not engage in Masonic interactions with irregular or clandestine Grand Lodges or Masons.

Beyond its primary mission, the committee maintains a vigilant watch over the entire Masonic landscape. It observes the actions of other Grand Lodges and stays abreast of current events within the Fraternity. Operating under the authority of the Constitutions, this committee acts as a fact-finding body in our Grand Lodge's foreign affairs. It addresses matters that require discussion or action, diligently performing the detailed work necessary to uphold harmony between our Grand Lodge and the broader Masonic world.

#### **Jurisprudence Committee**

Masonic Jurisprudence serves as the Common Law of Freemasonry. It is a set of principles and guidelines that govern our Fraternity. Within its scope it encompasses the Ancient Landmarks, which trace back to 1721, as well as the Constitutions, Rules and Regulations specific to the Grand Lodge of the State of New York. Importantly, Masonic Jurisprudence should not be confused with civil law; the two exist as separate and distinct entities.

The Committee on Masonic Jurisprudence is a standing committee and plays a pivotal role within the Grand Lodge. Its responsibilities include reviewing both domestic and foreign correspondence, addressing inquiries related to Masonic Law and confirming the usages, privileges and customs of our beloved Fraternity.

The Committee's membership is all Past Grand Masters of the Grand Lodge of the State of New York. Their collective experience, wisdom, history and knowledge span over 400 years. Additionally, the committee serves as an advisory body to the Grand Master.

#### The Masonic Brotherhood Foundation

The Masonic Brotherhood Fund Committee is a Standing Committee within the Grand Lodge. Operating under the umbrella of the Masonic Brotherhood Foundation, Inc., a registered 501 (c)(3) charitable corporation, it has a clear and noble purpose: to provide aid, assistance and support to New York Masons and their families in emergent situations. The Foundation serves as the Grand Lodge's official charitable fundraising and distribution system. Within this organized and professional framework, Masons of the Grand Lodge have the opportunity to fulfill their Masonic obligations. Many well-established and commendable charitable efforts fall under its purview. These include the Masonic Home, the Masonic Medical Research Institute, Masonic Military Veterans, Livingston Library, the Battle Within, various Youth Groups and Camp Turk. But the spirit of brotherhood extends beyond state lines. New York Masons also lend a helping hand to other Grand Lodges facing natural disasters. Examples include hurricanes, floods, fires or other natural disasters. Additionally, they stand in solidarity with those affected by the ravages of war.

Brothers may choose to donate specifically to the Grand Master's Allocation. This flexible fund empowers the Grand Master to direct resources where they are most needed, ensuring a compassionate and responsive approach to charitable endeavors.

#### **Grand Lodge Educational Assistance Committee**

The Grand Lodge Educational Assistance committee exists to support the children and grandchildren of Master Masons (including those of deceased Brothers) in their pursuit for higher education. This effort stems from the desire to aid the children and orphans of Masons, which began with the opening of the Masonic Care Community in Utica in 1893.

The monies provided are in the form of a grant. Financial grants can be used by the recipients however they see fit. The committee operates a web-based application process. As applications are received they are logged and a checklist is created to follow each application to its conclusion. The Educational Assistance Program is currently funded by the Trustees of the Masonic Hall and Home.

#### **Committee on Law Enforcement**

The Committee on Law Enforcement (LEC) is a Standing Committee of Grand Lodge consisting of seven members and several consultants. The duties include conducting investigations into violations of Masonic Law and our Constitutions. Depending on the violation, these investigations may be carried out by one of the committee members or by assignment to the respective DDGM for minor intra-District issues. The LEC is also charged with the task of inspecting the books, accounts and records of a Lodge Under Dispensation prior to a Charter being granted.

Consisting of active and retired law enforcement officers with decades of experience, the committee is tasked with gathering evidence to support any charges in violation of Masonic Law; presenting these to the Grand Master for his endorsement and sending the case to the Proctor for the preparation of formal charges. The Committee is, arguably, one of busiest Grand Lodge committees, needing almost daily attention. By working hand-in-hand with the Office of the Proctor, the caseload is being efficiently managed. As our membership screening process improves, the caseload will, one day, hopefully diminish.

#### **Technology Committee**

While the Technology Committee has a broad mandate to assist in the bringing of technological resources to the Grand Lodge of the State of New York and its associated Lodges, it functions with three primary points of vision:

1. The Technology Committee provides an architectural

- view of technology, encouraging standardization, consistent use and secure adoption of technology by the Craft.
- 2. The Technology Committee assists the Lodges and committees of Grand Lodge with their technology use. This includes guidance with technological tools (ex. Zoom), provisioning of systems (ex. Hiram) and assistance with technology-based activities (ex. recording and transmission of Grand Lodge Programs.)
- 3. The Technology Committee assists Grand Lodge and its associated entities with preventative and post-event information security efforts. This includes but is not limited to advising on best practices, reporting and incident response.

The committee is actively seeking Brothers who would like to assist in this effort in their region of the state. Individuals with a strong background in Technology Deployment, Technology Education and/or IT Incident Response should apply to weisbm@ix.netcom.com.

#### **Committee on Awards**

The Committee on Awards is a standing committee in the Constitution and is directly responsible for the investigation and approval of the Dedicated Service Award. Members of the committee provide an unbiased evaluation of Brothers nominated for this award, and then take a vote. The vote of the chairman is a tie-breaker for approval.

This award has a time frame for submission, which is September 1 to November 12 of the previous year. All approvals are subject to the final consent of the Grand Master. Recipients are notified in January of the award year.

The committee is also responsible for the DeWitt Clinton, Jacob Morton and Grand Lodge Certificate of Appreciation for Excellence in Service to the Community. Members of the committee follow the same process of evaluation and vote for the candidates for these awards. Nominations may be submitted throughout the year. Recipients are notified within a short time after submission.

The committee is responsible for the Years of Service awards. Although Lodge Services handles the certificates, pins, etc., this committee submits the totals of certificates, pins, etc. in its Annual Report.

This committee has a Chairman and eight Committeemen. There are two committeemen in each if the four Regions of the state. This number is sufficient to investigate and vote on nominees.

#### **Constitutions Committee**

The Constitutions Committee is a Standing Committee of Grand Lodge. There are presently nine members. The primary function of the Committee is to review all propositions to amend the Constitutions, Masonic Law and Rules of Order of Grand Lodge. (See Masonic Law: Section 332 and Rules of Order section XI sub.8.)

The criteria are the same for every proposal submitted: is it clear, concise and in acceptable language for inclusion in our Constitutions? Will it benefit the Craft, does it conflict with another Section or some other Masonic Law? Will it have a positive rather than negative impact and will it assist in the administration of Grand Lodge?

The Committee members discuss these proposals, using their insight and knowledge. Their conclusions are in keeping with protecting these cherished documents for the brethren of the Fraternity. The Committee believes these documents should be amended only when absolutely necessary and not just for the sake of change.

These proposals are then reviewed and discussed via e-mail, Zoom or at a meeting of the Committee prior to the Committee's annual meeting, which is held approximately one week prior to the Grand Lodge Annual Communication. After discussing these proposals the Committee votes to recommend approval, disapproval, referral to another Committee or have it tabled. It is then brought to Grand Lodge for a vote of the brethren who will have the final say.

The Committee encourages the Brothers to read and understand the Constitutions and Masonic Law. Before submitting a proposal, consider whether or not the proposal is really necessary. Do the research and remember that these articles are what make Masonry such a great institution.

#### **Custodians of the Work**

The Custodians of the Work are a Constitutional committee consisting of seven members that is charged with caretaking the Standard Work and Lectures of the Grand Lodge of New York. This responsibility takes many forms, including periodic restorations, adjustments, updates and changes to the ritual in order to best serve the brethren in the present age. Examples are the Constitutional proposal to allow opening and closing on any of the three Degrees of Masonry and creation of opening and closing rituals for Entered Apprentice and Fellowcraft Lodges; creating, correcting and modifying the written and other materials used by the brethren in learning and performing our Ritual, the best example of which is the 2019 edition of the blue Ritual book; working with the Grand Lecturer and issuing occasional guidance to ensure that our rites and ceremonies are performed correctly and appropriately; and other activities with relevance to our ritual.

The Custodians are nearing completion of a ten-year project to review all of our printed assets and the ritual contained within them. The first phase was thoroughly reconsidering, reorganizing, reformatting, regularizing, supplementing and expanding the blue Ritual Book. This took over six years to accomplish, and the book which resulted is unsurpassed in the worldwide Masonic community. Soon we will bring forth a new Monitor containing all the exoteric material in our Standard Work and Lectures. There has not been a real Monitor published by our Grand Lodge in thirty-five years, with the result that many Lodges still perform ceremonies from old Monitors that have not been valid for over twenty years. The forthcoming Monitor contains not only the exoteric material from the Degree rituals, but also such materials as annotated schematics showing the basic pathways of the Drama of the Hiramic Legend and a special script for the Narrator; scores for the musical selections specified in the ritual, including simplified versions with just the melody and chords; an updated Installation of Lodge Officers in both the contemporary "Tiler to Master" order and the traditional "Master to Tiler" order; illustrations of the correct configuration of the apron for each Degree; an expanded "Basic Principles" section setting forth guidance on common questions such as proper pronunciation of Lodge numbers, how to wear the apron, declaring Liberty of the Lodge, what to do with additional volumes of Sacred Law on the altar, proper positioning and configuration of the Square and Compasses; and much, much more. We believe the new Monitor will be every bit as outstanding as the 2019 blue Ritual Book.

All of these undertakings are done with deep respect and consideration for the many years of history and tradition which have accrued around our rituals and ceremonies, an understanding of the interests and preferences of incoming Masonic generations and the goal of providing the brethren with the best possible materials to aid and guide them in learning and performing our beautiful Masonic ritual. Perhaps most importantly, all of the foregoing is done—and can only be done—in close consultation with Masons from every corner of the state. We not only proactively reach out to the brethren in our various regions and Districts, but also welcome communication of ideas, observations, compliments and complaints from any Brother who would like to share his thoughts with us. A process has evolved, written and approved by Grand Masters over the years. It is designed to protect the assets of the Lodges and the members. The process seems daunting to some, but it is preferable to surrendering a charter. The Committee and your District Deputy Grand Master are here to help.



The cost is \$20 per medallion and it may be ordered through the Lodge Secretary from Lodge Services.

I want to impress upon you that there is a cutoff date for the Dedicated Service Award Recommendation. The forms and information must be postmarked on or before November



12, 2024. There is a lengthy procedure in place with the committee voting on, the Grand Master approving and the required notifications being made for each recipient. We encourage the timely submission of the nominations for our distinguished Brothers.

The Community Service Awards (DeWitt Clinton, Jacob Morton, and G.L. Certificate of Excellence in Service to the Community) have no cutoff date and will be processed as they are received. The Lodge and DDGM will be notified within a short period of time if the nominee has been approved to receive one of the awards.

Brother Nino Barbera's vision encompasses not just academic enrichment but also societal well-being. Through the Mnemosine Association he has orchestrated charitable activities and significant contributions aimed at uplifting communities. Noteworthy initiatives include substantial donations to the Sicani Lions (Leoni Sicani Onlus). This organization supports disabled children who play wheelchair hockey, for whom he built a sports center for their events and donated a team bus. # Eulogy for ME and RW Edmund "Ted" Dale Harrison

A las, another Great Oak has fallen within the forest of our fraternal workings. We sorrowfully announce the passing of the Most Excellent and Right Worshipful Edmund "Ted" Dale Harrison, who laid down the working tools of a Mason on Sunday, July 14, 2024 during a brief residency within a rehabilitation center in New York City.

Perhaps solace can be found in the poetic words of Professor Amos Russel Wells reflecting upon "The Comfort of the Woods":

I understand my comrades of the woods, And they know me completely; not an Oak But is my Brother, strong, reserved, sincere. Along the happy, peaceful forest ways That wind so intimately through the trees I hold a calm communion with my friends, The pines and gentle birches. Day by day insensibly the bond is closer drawn With beckoning of branches, Of subtle fragrance, melodies of birds, Flickers of sunlight on level leaves, A thousand sweet enchantments pure and good. This air dissolves my fretfulness and fears; They fall into the green depths of the dell, The cheery brook carries them away, The bushes brush them off. I enter here With furrowed brow and heavy-burdened heart; But little unseen hands are softly pressed Upon the frowns, and little unseen hands Tug at the burdens till they are all gone. Ah, what am I that these my friends Should minister to me so graciously? Do they not know my follies and my sin? Yet with a mother's blind, forgiving love They cleanse what they will not see. Nor do they only wait for me, Withdrawn, expectant; but amid the din Of cities, and upon the crowded streets, I feel the brick and mortar fade away, And find the woods around me once again I hear the woodland murmurs like a hymn, And on my troubled spirit lies once more, The peaceful Benediction of the Trees.

A gentleman of ambassadorial qualities, Brother Ted Harrison, who had just celebrated his 85<sup>th</sup> milestone, was born on May 2, 1939 in St. John, New Brunswick, Canada to Major Kenneth M. Harrison of the Canadian Army and K. Marion Lombard of Montreal. Sadly, Brother Ted's father was killed in action in Italy during World War II.

Brother Ted Harrison attended and then graduated from Westmount High School in 1956. He studied and graduated with honors at the Institut d'Art Photographique on a scholarship received from the local Rotary Club. Brother Ted



Harrison launched a very successful business career in 1957 when he entered into a partnership with C.A. Nicholls, combining a retail camera store with a photographic laboratory and studio named Acme Photo Ltd. Over the years, the business expanded into a full service Professional Commercial Studio and Photo Lab in tandem with two retail camera outlets. He remained active in the commercial and retail photography business until 1963, when he sold the business.

Emigrating to the United States in 1963, Brother Ted Harrison established a wholesale photographic accessory distributorship in Greenfield, Massachusetts. His business

quickly expanded throughout the territory of New England and New York. Eventually, it was incorporated in 1973 and became known as N & H Sales, Inc. moving its headquarters to Hingham, Massachusetts.

N & H Sales, Inc. continued to grow and in 1975 Brother Ted Harrison opened a new branch office and warehouse in New York City, which provided additional service to the East Coast of the United States. The following year, capitalizing on the enterprise while at its peak, Brother Harrison sold the company to POSSO SA of Lausanne, Switzerland, where he stayed onboard with the new owners as their Vice President of Sales and Marketing.

A new and more lucrative opportunity then presented itself with the Uniphot Corporation, which is one of the largest suppliers of photographic accessories in the United States. Brother Harrison accepted a position as their Managing Director of the Uniphot Corp.'s International Direct Marketing Division in 1980. Within a period of five years, Brother Ted Harrison was on the fast track with a promotion to Vice President of Marketing, where he superintended fiftyplus sales representatives, managed five warehouses and was directly responsible for handling several major national and corporate accounts, such as K-Mart, Wal-Mart and Target. During his five-year tenure Brother Harrison personally built the company's gross sales up from \$13 million to \$20 million.

Subsequently, in 1988, Brother Ted Harrison launched a new business venture representing diverse manufacturers called Harnich Sales. This is a successful ongoing business enterprise still in operation today.

Brother Ted Harrison was a devout Christian with a strong religious upbringing. He was baptized in the Anglican Church of Canada, where he was for many years an active member of Christ Church Cathedral in Montreal. During the early 1960s Brother Harrison affiliated with Robbins Memorial Congregational Church in Greenfield, Massachusetts, where he was elected to the Diaconate. Upon settling in New York City in the late 1970s, Brother Harrison became a communicant at

Continues from page 37-ME & RW Ted Harrison Eulogy the Episcopal Church of the Incarnation, where he served as a Vestryman, advancing to the office of Senior Warden of the Church.

Never one to shirk responsibility or a good challenge, Brother Harrison volunteered his time and talent on the Restoration Committee of the Church of the Incarnation, where as co-chairman he helped to raise over \$1 million towards the successful preservation of the church's historic building.

A familiar theme to all good Masons, our first duty is to God, followed by our loyalty and duty to Country, Brother Ted Harrison volunteered in 1965 as an enlisted member of the United States Army. He went to Boot Camp at Fort Dix, New Jersey, where he was singled out by the Commandant, Major General Beauchamp, for a commendation for exceptional service. He later became an active member of the 26th Division of the National Guard in Massachusetts, where he was assigned to be the photographer to the Commanding General. Brother Harrison honorably concluded his military service in 1971 with the rank of Staff Sergeant.

Brother Ted Harrison's Masonic career began in 1969 when he was Raised in Republican Lodge, Greenfield, Massachusetts, where he was eventually elected and installed the Worshipful Master from 1974 to 1975. With his relocation to New York City, Brother Harrison petitioned and was elected in 1992 a plural affiliate member of Independent Royal Arch Lodge 2, where he took up the mantle of Worshipful Master from 1995 to 1996. He also served as the Worshipful Master of the American Lodge of Research from 2005 to 2006. He was one of the founding members of John Philip Sousa Lodge 1192 in New York City.

Gaining stature in the New York City Region, our Brother was recommended and received a commission from then Grand Master Earle J. Hino, Jr., to serve as the District Deputy Grand Master of the First Manhattan District from 1996 to 1998. He also served on the Grand Lodge Masonic Fraternity on Campus Committee and held the position of Chairman Emeritus from 2016 until today. RW Brother Ted Harrison was honored in 2014 with the highest award that the Grand Lodge F & AM of the State of New York can bestow upon a worthy Mason, namely the Grand Lodge Distinguished Achievement Medal.

Brother Ted Harrison's involvement and commitment with the concordant bodies of Freemasonry is very extensive and widespread. A sampling of those bodies and offices held are as follows:

Climbing the stairway of the Scottish Rite, Illustrious Ted Harrison was received into the Valley of Greenfield, Massachusetts in 1970. He later affiliated with the Valley of New York in 1991 and then the Valley of Westchester in 2001. He was elected to the office of Most Wise Master in 2003 and Sovereign Master in 2004 of the Valley of Westchester. Ill. Ted Harrison was Coroneted the Thirty-third Degree in 2006 by the Supreme Council, Ancient Accepted Scottish Rite, Northern Masonic Jurisdiction.

Brother Ted Harrison was Exalted into the York Rite as a Companion of Franklin Chapter of Royal Arch Masons in Greenfield, MA in 1970. In 1981 he affiliated with Jerusalem-Amity Chapter 8 and Ancient Chapter 1 in New York City. Excellent Companion Ted Harrison was elected and anointed as the Excellent High Priest of Ancient Chapter 1 in 1988. He was honored as the Royal Arch Mason of the Year by the First Capitular District in 1983 and was recognized by the Grand Chapter of the State of New York for having Exalted twenty-eight new Companions in 1988.

In the early 1990s Right Excellent Ted Harrison was appointed and served as the District Deputy Grand High Priest of the First Capitular District and served as the President of the Fraternal Union of Anointed High Priests. His elevation into the Grand Line of the Grand Chapter of Royal Arch Masons of the State of New York began in 1993 with his appointment as the Grand Master of the First Veil, which culminated with his election to the office of the Most Excellent Grand High Priest for 2002 and 2003.

Continuing his journey along the path of the York Rite, Most Excellent Harrison was received into Titus Strong Council, Royal & Select Masons of Greenfield, MA in 1973. He was presented with the Super Excellent Degree in 1974 by the Grand Council of Massachusetts. Brother Harrison affiliated with the Brooklyn Council 4 in 1985 and affiliated with the Columbian Council 1 in New York the following year. He served the Council as the Illustrious Master in 1990. The Grand Council of Cryptic Masons of the State of New York appointed ME Ted Harrison to the office of Grand Sentinel in 1990. Amongst his many awards, ME Harrison was presented with the Meritorious Ish-Sodi Award for sponsoring the membership of twenty-five new Cryptic Masons in 1992.

The year 1993 witnessed ME Ted Harrison's elevation as the Thrice Potent Illustrious Master of St. George Council, Order of the Anointed Kings, where he was conferred with the Order of the Ninth Arch by the General Grand Council of Cryptic Masons International.

Eminent Sir Knight Ted Harrison was knighted in 1973 in Greenfield, MA by Connecticut Commandery 3, Knights Templar. He affiliated with Morton Commandery 4 in New York City and served as its Commander from 1985 to 1986. Right Eminent Harrison was appointed the Grand Representative of the Grand Commandery of Tennessee near the Grand Commandery of New York in 1990 and he served as the Deputy Zone Commander for Zone Two from 1991 to 2008. He was the recipient of the Pro Merito Award, the Knight Templar Cross of Honor and the Knight Commander of the Temple Award from the Grand Encampment of Knights Templar of the United States of America.

In 2004 the Grand Chapter of Royal Arch Masons of the State of New York elected Most Excellent Ted Harrison to the office of General Grand Scribe, placing him in the line of the General Grand Chapter of Royal Arch Masons International. His ultimate elevation and election to the office of General Grand High Priest of that august body came to fruition in 2011, an office he held until 2014—a well-deserved honor for a man of exceptional talent and exquisite pedigree. Most Excellent Ted Harrison's work for the Royal Arch Masons throughout North America, Central and South America, Europe, Asia and Africa has been legendary.

### Focus on Youth Mental Health

America is facing a youth mental health crisis. Politico recently surveyed mental health and medical professionals on the state of youth mental health. Among respondents, 88% said it had worsened, with 53% saying it had "significantly" worsened. Some of this decline is due to the shutdown from COVID19, some of this is from lack of social interaction and some of it is from social media. Regardless of the cause, we are facing an unprecedented crisis in youth mental health. This mental health crisis is sadly manifesting itself in increased self-harm and suicide attempts. Recent research by the Center for Disease Control shows that it is the second leading cause of death among Americans aged 10-34. Among high school students, 22% reported giving serious thoughts to suicide in the past year, with 10% having actually attempted it. These statistics increase among the LGBTQQIP2SA community, women and racial and ethnic minorities. Each of us can play a critical role in helping to address these issues.



- 1. If someone is talking about harming himself, take it seriously. Call the 988 Suicide & Crisis Lifeline.
- 2. Create avenues to open dialogue with your children. Often this can be as simple as asking how they are feeling. Sometimes it is creating the opportunities to have that dialogue—perhaps watching a game or going fishing.
- 3. Be open to talking about your own feelings and how you cope. This could be a conversation where you share how you are feeling or how you may cope with your own emotions. Youth seeing parents talking about their own emotions will help them share their feelings.





- 4. Make sure you let them know you are there for them and you will support them no matter what. Creating that support will encourage them to share things that may be bothering them.
- 5. Look for changes in their daily routines. We all remember our own adolescence and how difficult it may have been for us. If you see your child changing behaviors or changing dietary habits or no longer enjoying things she once did, this can be an indicator of something more serious going on.
- 6. Make sure you are taking care of yourself. Parenting is the hardest job in America. You want to make sure you are taking care of yourself, seeking help when you need it and engaging in other self-care practices.
- 7. Take advantage of one of the many trainings our committee is working on this year around mental health and best practices. Each one of us plays a critical role in helping to make this world a better and safer place for youth.

### Masonic Youth Advisor of the Year

Each year, the Scottish Rite Northern Masonic Jurisdiction honors one adult volunteer from each state as their Masonic Youth Advisor of the Year. This year the New York Council of Deliberation, based on recommendations from the different youth groups, selected Worshipful Brother Mark Alvarado as the advisor of the year.

Worshipful Brother Alvarado is a long standing volunteer for DeMolay.

DeMolay historians will recount that a critical component of the early success of DeMolay was "Dad" Charley Boyce, described as "a man with graceful charm." He was constantly working in the background to help promote and keep DeMolay going. What Charley Boyce did for DeMolay in 1922, "Dad" Mark Alvarado does now with his work with DeMolay in 2024. "Dad" Alvarado was a member of David J. Nye Chapter in Ohio DeMolay, rising to the level of State Scribe, a key senior youth administrative role with the Ohio State Council. He was recruited to work for DeMolay International in Kansas City in their membership services office and the store. When NY DeMolay was hiring a new field representative to support our membership growth in 2003, we had many applicants but "Dad" Alvarado was head and shoulders the best candidate for the job. In addition to the work he was doing in the office, "Dad" Alvarado became involved with Mohawk Valley Chapter, serving first as Chapter Advisor and Chairman. He joined the Valley of Utica, Ziyra Shrine and many other Masonic Bodies. When the grant for membership services ran out and NY DeMolay was forced to eliminate professional staff, "Dad" Alvarado had a choice to go back to Kansas City, go back to Ohio, or remain with us in New York. Taking a job with the local public school district, "Dad" Alvarado has made the decision to stay and we are so much better for it. "Dad" Alvarado has remained committed to volunteering with DeMolay, and now in his 21st year.

"Dad" Alvarado has mentored hundreds of DeMolays, both in Mohawk Valley and across the state. He has served as a volunteer Director of Membership for the state, State Chapter Dad, LeadCon Advisor and so many other activities. "Dad" Alvarado's approach is an amazing one. He sits with the young men and listens to their concerns and ideas and figures out the best way to help them achieve their results. If it's a young man trying to plan a fundraiser, or an outing for putt putt, or a state wide convention. His approach echoes the same approach that "Dad" Charley Boyce did. "Dad" Alvarado also volunteers to DJ our annual state conventions every year for free. If "Dad" Alvarado were to charge the commercial rates for the hours and equipment he uses our DJ bill would be thousands of dollars. His help and assistance have been critical for making sure DeMolay is successful.

Lastly, our Summer Fellowship program saw a record number of participants this year. Nineteen students were accepted to engage in intensive scientific research projects. That is what the researchers at Masonic Medical Research Institute (MMRI) are doing for people like my three sons, John, Jameson and Dominic, who all have autism. My name is RW Pasquale (Pat) Imbimbo Jr., Mason of thirty-three years. I am writing to seek your help.

Autism Spectrum Disorder (ASD) can present significant difficulties for individuals and families like mine. With my oldest son, John, challenges started as soon as he was born. At just twenty-two days old he had his first open heart surgery due to complications from his condition. Jameson and Dominic are my fifteen-year-old twins. Jameson cannot communicate at all; he is non-verbal and struggles. Dominic can talk but in "cartoon speak." Although he is fifteen years old, he behaves like he is only five. My wife and I strive to provide them with a better life, which is why we started our farm: to give them meaningful work opportunities. However, we cannot do the science part. That is where MMRI comes in.



#### Autism Research at MMRI:

Through cutting-edge research initiatives, Dr. Maria Kontaridis and her team are uncovering new insights into the complex genetics of ASD by comparing the DNA of children diagnosed with autism to their unaffected parents or siblings. They are making leaps and bounds here at MMRI, identifying novel genes that can potentially lead to new drug targets for the treatment of patients with autism.

"My family is excited, I'm excited! Their research is giving my family hope that their lives can one day be just a little easier. That is what I want and what I am fighting for."

Here is a Camp Turk story:

Thirty-two years ago in July of 1992, a just-turned 13-yearold (and quite socially awkward) kid was really debating with his parents (and grandfather, a Mason) about the notion of three weeks away from friends at a camp somewhere in the Adirondacks. Fast-forward to 2024, that now-dad is really excited to drop off his 8-year-old daughter for two weeks of adventure at the same camp.

The notion of full circle comes to mind as I write this. While that shy kid thirty-plus years ago was initially apprehensive of the camp experience, the rest, as they say, is history. The first person he met that day was a charismatic 18-year-old from Manchester, UK. This person was not only the counselor for

the sky kid, but since then has served as his mentor in the many years he worked at camp with me, was in my wedding and is incidentally dropping his kids off at Camp Turk in 2024. Full circle.

My initial Camp Turk experience went from trepidation to love: as a camper for four years and working there for seven more, ending as head counsellor and running the boating program. More astounding is the prolific impact camps (including Camp Turk) can have on young people and how it can shape their lives. Without that camp experience the path would have been decidedly different. I would not have had the opportunity to travel a dozen times to the UK, visit friends in Australia or randomly run into camp people while trekking in New Zealand. I would not have had an international contingent in my wedding, and I certainly would not be (nearly) as excited as my daughter for camp drop-off.

In sum, I am so happy that I was able to experience the magic of a place like Camp Turk thirty years ago and am beyond ecstatic at the opportunity for my daughter to hopefully start her own path. The story is not yet over.


# **Ambassador Abroad**
